



## STUDENT RESOURCE SCHEME INFORMATION FOR 2023 YEAR 12

Dear Parent/Caregiver

The Queensland Government supports students' education by providing funding for instruction (eg teachers), and facilities (buildings, amenities, furniture). Funding does not extend to individual student resources such as textbooks, computer or musical equipment for personal use, and many items used/consumed by the student in the classroom. Supply of these items is the responsibility of the parents/guardians. To provide parents/guardians with a cost effective alternative to purchasing textbooks and/or resources, Wellington Point State High School operates a **Student Resource Scheme (SRS)**. **The objective of the SRS** is to provide a convenient and cost-effective way for students to access the educational resources required for them to engage with the curriculum for their education. The scheme is fully endorsed by the School's Parent and Citizens Association (P&C). The SRS is managed by the school and operated in accordance with Section 51 of the Education (General Provisions) Act 2006. **The cost of the 2023 SRS for Year 12 is \$380**. A breakdown of this fee is outlined on the next page. **(Please note the Senior Retreat has been added into this fee)**.

Please note that this **Student Resource Scheme** is a voluntary scheme, although there are a number of mandatory charges (\*\* on attached list). Nearly 100% of parents in the past have elected to join due to the convenience and reduced financial commitment. If a parent chooses to participate in the scheme, a fee will be due and payable for the resources provided to the student.

### WHEN DO I PAY TO PARTICIPATE IN THE SCHEME?

To ensure your student receives their textbooks at the start of 2023 a **deposit of \$100 is requested by the end of 2022**. This deposit will cover the Year 12 Retreat payment. To be eligible to attend the Retreat this deposit must be paid. The balance of \$280 is to be paid by the end of Term 2, 2023. For new students please complete the Student Resource Scheme Participation form (1 per family) and return to the Cashier's Window regardless of which method of payment you choose.

If you choose not to participate in the scheme, a list of resources covered by the scheme can be provided for the respective year level. You are then expected to provide these resources for your child at your own cost. In this case the SRS form must be returned to the Cashier's window with your chosen option to not join the scheme selected. The **Student Resource Scheme** is the most cost effective method to equip students with their requirements. On the attached list the items with \*\* indicate mandatory charges whether you participate in the Scheme or not.

Allocation of textbooks occurs on a class by class basis within the first two weeks of the school year to all financial scheme members. If a student enrolls (or leaves) during the year, the charge for (or refund from) the Student Resource Scheme will be **on a pro-rata basis**. **Refunds will also be subject to a service fee of \$20.00 to cover the cost of non-returnable items such as homework diary/planner, duplicated notes, student ID card etc.** and will be dependent upon books and resources being returned in good condition. No refunds will be provided if a student leaves the school after the end of term 3. Any refunds due from school activities will be applied against outstanding resource hire debts for that student or their siblings.

If you are suffering genuine financial hardship please make an appointment with the Business Manager to discuss ways in which the school can provide assistance. For families receiving Centrelink payments, the SRS payments can be made via Centrepay. Minimum payments are \$20 per fortnight.
