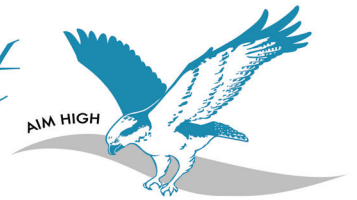

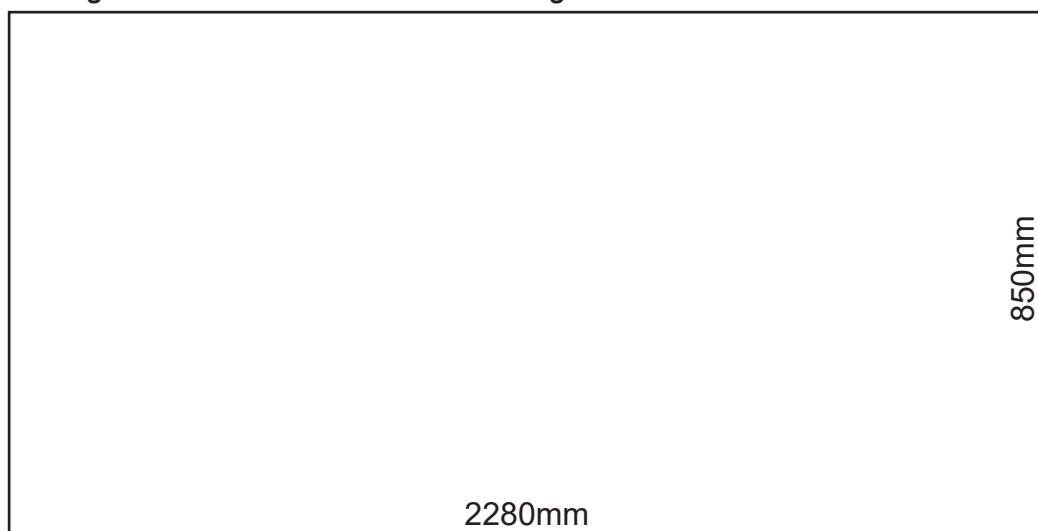
SIGN SPECIFICATION AND PRICING

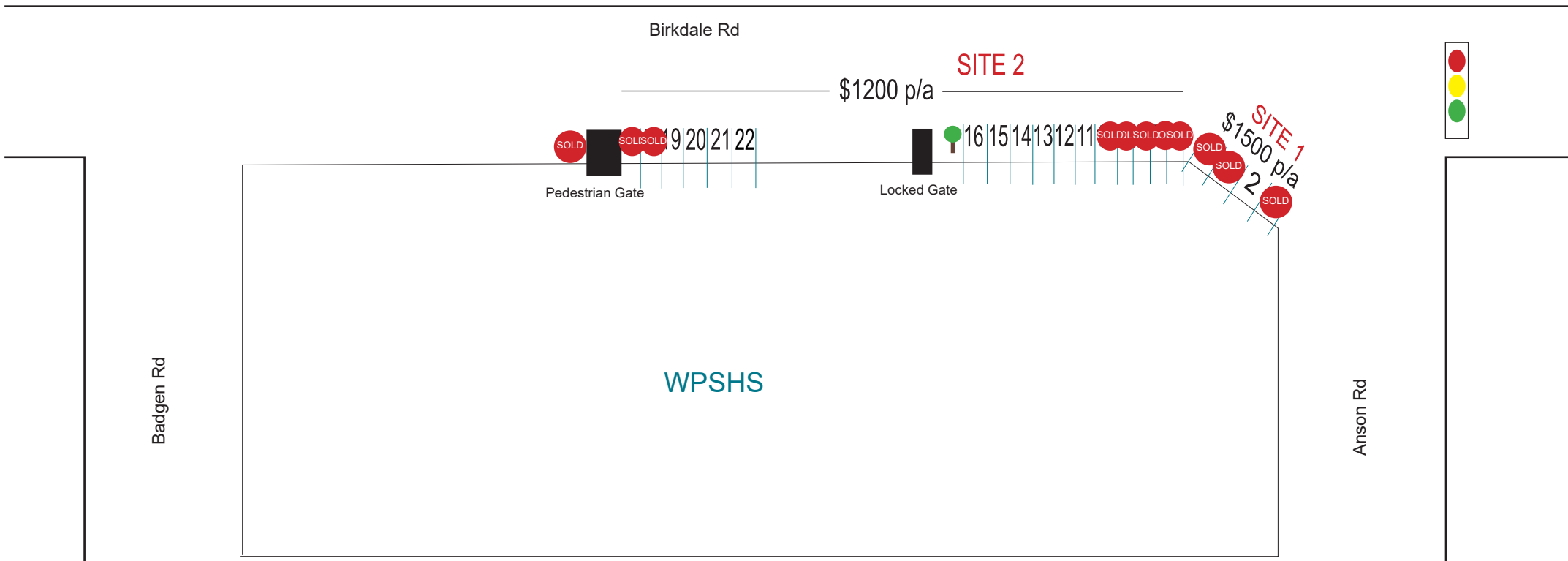
Wellington Point State High School has final approval of supplied artwork under the following conditions:
